Biographical Sketch. Linda H. Aiken (1943-) is Trustee Professor of Nursing, Professor of Sociology, and Associate Director of the Leonard Davis Institute of Health Economics, at the University of Pennsylvania, Philadelphia. She was educated at the University of Florida (1964, B.S.N. Cum Laude, Nursing and 1966, M.N., Nursing) and the University of Texas at Austin (1973, Ph.D., Sociology and Demography). She was a postdoctoral research fellow in Medical Sociology at the University of Wisconsin at Madison (1973-1974).

Aiken is a past president of the American Academy of Nursing and a member of the Institute of Medicine of the National Academy of Sciences. She has been an active participant in health policy issues as a health policy researcher, as a member of national policy commissions, and as an architect of a number of national multiple site demonstrations testing new ways of organizing and financing health care. Aiken is nationally known for her research on the nursing shortage and served as a member of the recent Secretary's Commission on Nursing as well as the 1983 Institute of Medicine Study of Nursing. She has also participated in national policy initiatives involving the elderly and long-term care. She was a member of the Advisory Council on Social Security chaired by Otis Bowen and a member of the Wyden Commission on long term care insurance.

Robert Wood Johnson (1893-1968) established a foundation bearing his name in 1936, four years after becoming president of the Johnson & Johnson Company of New Brunswick, New Jersey. The Robert Wood Johnson Foundation was established as an independent philanthropic agency whose interest focused on the improvement of health care in the United States. Johnson had willed his personal wealth, including his stock in Johnson & Johnson, to the Foundation. At the time of his death in 1968, his personal wealth was valued at more than \$300 million. Johnson wealth increased in value from \$300 million to nearly \$1.2 billion during the four years his will was in probate.

The Robert Wood Johnson Foundation was established in 1936 by Robert Wood Johnson (1893-1968), four years after becoming president of the Johnson & Johnson as an independent philanthropic agency interested in improving health care in the United States. The Foundation's programs are divided under broad divisions such as "National Programs," "Improving Health Services," "Research and Evaluation," and "Medical Education."

Aiken served in a variety of capacities at the Robert Wood Johnson Foundation. She began served as a program officer, 1974-1976; director of research, 1976-1979; assistant vice president, 1979-1981; and vice president, 1981-1987. While vice president, she designed a \$100 million demonstration to improve care for the chronically mentally ill for which she received an unusual Joint Secretarial Commendation from the Secretary of the U.S. Department of Health and Human Services and the Secretary of the U.S. Department of Housing and Urban Development.

Summary. This collection documents Linda H. Aiken's work at the Robert Wood Johnson Foundation as well as the activities of the Foundation itself. Aiken's papers reflect her growth and advancement within the Foundation. The collection documents trends at the Foundation and areas of interest through the reports and other official documents generated by the Foundation. Institu-

tions supported by the Foundation usually consist of colleges and universities, hospitals, and other agencies providing health care services.

Series Description. This collection has been arranged into two series:

Series I. The Robert Wood Johnson Foundation Reports, 1972-1987

Series II. Linda H. Aiken Office Files, 1974-1987

Series I. The Robert Wood Johnson Foundation Reports, 1972-1987. This series consists of 135 folders of publications, reports and other official documents generated by the Robert Wood Johnson Foundation. Included are Foundation published annual reports (1972-1987); board reports (1972-1987) position papers (1972-1976), program proposals and applications (1986-1987), and miscellaneous reports generated in the 1970s and 1980s. The published annual reports (1972-1987) are public documents highlighting the funded programs of the Foundation. The board reports (1972-1987) are internal documents and consist of overviews of program proposals approved by the Foundation staff and presented for review by the board of trustees. Many of the proposals presented in the board reports include the institution name, amount of recommended support, the names of the Foundation staff members responsible for the proposal, and detailed narrative. First issued in 1972, the position papers (1972-1976) present staff recommendations on the Foundation's program objectives that should govern its mandate for the advancement of health care in the 1970s and beyond. Included with the position papers are chronological and subject indices. Program proposals applications (1986-1987) consist of correspondence and fully developed proposals generated by agencies soliciting support from the Foundation. Miscellaneous reports include both internal and public documents.

Series II. Linda H. Aiken Office Files, 1974-1987. The series is made up of the papers and other related documents created by Aiken in her many capacities at the Robert Wood Johnson Foundation. It consists of 79 folders and includes her official correspondence, chronologically arranged (1974-1987), appointment schedules (1977-1987), and miscellaneous documents from the 1970s and 1980s.
