### THIS MONTH IN CHOPR HISTORY

Seven years after the publication of Dr. Matthew McHugh's influential paper, "[Nurses' Widespread Job Dissatisfaction, Burnout, and Frustration with Health Benefits Signal Problems for Patient Care](#)", the costly phenomenon of nurse burnout still persists. In 2011, McHugh and co-investigators examined survey data from nearly 100,000 nurses and found that nurses who perform direct patient care in hospitals and nursing homes, when compared to other settings, experienced a much higher rate of job dissatisfaction, resulting from a high degree of physical, mental, and emotional exhaustion. The CHOPR paper received high acclaim; it quickly became one of the "Most-Read Articles" of the year in *Health Affairs*, and the Robert Wood

Johnson Foundation selected the manuscript as one of the "[Final Five](#)" most influential research articles. According to [Altmetrics](#), the paper ranks in the top 5% of all research outputs and PubMed Central, the NIH repository, lists hundreds of scholarly articles in which McHugh's paper has been cited. Today, burnout, job dissatisfaction and the quality of hospital care remains a big concern for the health care industry and the patients they serve. In the current issue of the *New England Journal of Medicine*, two separate articles discuss the causes of clinician burnout and the steps to reduce it. These are the

first articles to be published by the [Action Collaborative on Clinician Well-Being and Resilience](#), a new network of more than 50 organizations committed to reversing trends in clinician burnout, from the National Academy of Medicine.
